Sub : Requirement of Students' AADHAAR details for availing beneficiary schemes implemented by the Higher Education Department, Assam

Sir/ Madam,

With reference to the subject cited above, you are hereby informed that AADHAAR Number and AADHAR linked bank account of students shall be mandatory for availing various student related beneficiary schemes such as Fee Waiver Scheme, Mukhya Mantri Nijut Moina Aasoni and Mukhya Mantri Nijut Babu Aasoni as informed by the Government. (Also refer to the Video Conference held on 3rd June, 2026 with all concerned.)

Institutions are requested to ensure that valid AADHAAR - related information of students are furnished and updated through the SAMARTH portal.

In case a student does not possess an AADHAAR Number, the concerned Higher Educational Institution (HEI) shall take necessary steps to ensure that the student concerned applies/enrols for his/her AADHAAR and that the AADHAAR Number is uploaded in the SAMARTH portal at the earliest.

HEIs are further requested to verify the AADHAAR details of those which are already uploaded in the SAMARTH portal and undertake necessary corrective measures wherever the AADHAAR information is found to be incomplete, incorrect, or invalid. The institutions shall ensure timely updation and verification of AADHAAR -related information of all eligible students so as to facilitate smooth processing and release of Fee Waiver reimbursements and other beneficiary schemes.
