**ORDER**

The following conditions are hereby laid down for information of the appointees:-

1. The appointee concerned shall have to submit their joining report before the undersigned on 18.05.2022.
2. However, his / her posting will be given after the process of counselling of posting is completed at District level.
3. The appointee concerned shall also have to furnish Joining Report alongwith an undertaking before the undersigned as prescribed by the Finance (Budget) Department vide letter No. B.W.3/Pt-II/1, dtd. 25.01.2005 regarding acceptance of "New Pension Scheme" as under:-  
 "I understand and accept that Government servant joining the service in the State Government on or after 01.02.2005 shall not be governed by the existing Assam Service (Pension) Rules, 1969 and orders issued there under from time to time and that their pension and other retirement benefits will be governed by a set of New Pension Rules, which are being introduced in the line with the Contributory Pension Scheme of Government of India".

4. On receipt of any adverse report / irregularities from the competent authority on "Back Office Verification" of relevant documents / testimonials in respect of any candidate, the appointment order of such candidate will be cancelled forthwith without any notice and without assigning any reason thereof.

5. The appointing authority will have the right to cancel the appointment of the candidate in case he / she has been selected and appointed on the basis of any fraudulent documents and is detected by the authority in future.

6. Appointees will submit a notarised affidavit swearing that he / she is not involved in any criminal or unlawful activities in the eye of law. Appropriate steps will be taken in case of misrepresentation of facts.
